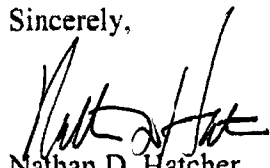
RE: Avalon at Pine Mill Ranch, Section 1- Street Name Change

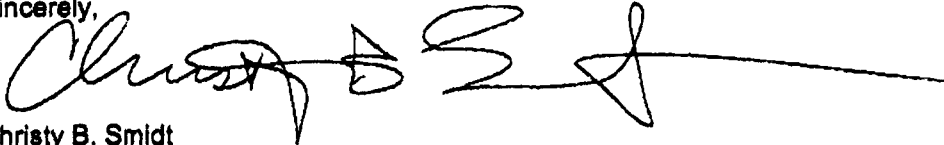
RE: Nothingham Bluff Lane Street Name Change

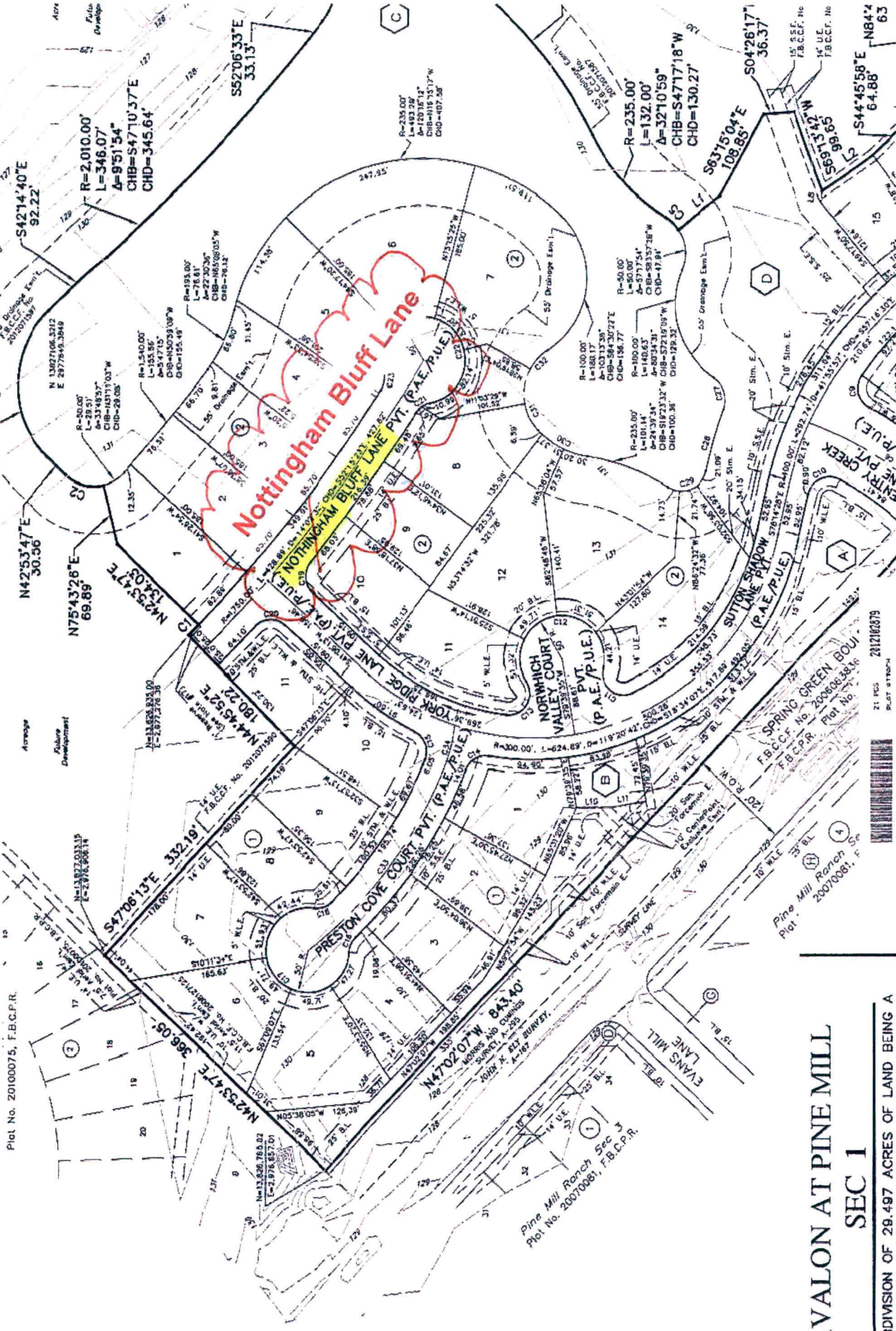
