The Department of State Health Services (DSHS) and FORT BEND COUNTY (Contractor) agree to amend the Program Attachment # 001A (Program Attachment) to Contract # 2013-042335 (Contract) in accordance with this Amendment No. 001B: Tobacco Community Coalition, effective 03/12/2013.

The purpose of this Amendment is to revise the TCC Program Attachment, Section B. #2, #7, and Section E. Reporting Requirements adding TPCC Final Evaluation Report Draft due 6/15/13 and TPCC Final Evaluation Report due 8/15/13, and removing the County Epidemiological Assessment Report and Strategic Plan.

Therefore, DSHS and Contractor agree as follows:

- B. SERVICE REQUIREMENTS listed below are revised to read as follows:
  - 2. Conduct an annual needs assessment that determines the tobacco use and related health consequences and tobacco-related health disparities within the targeted community in Section III, Program Service Area stated below. Conduct a community resource assessment that identifies existing strengths and assets of community tobacco prevention and control and substance abuse prevention programs and other services in the targeted community in Section III, Program Service Area stated below. Convene a CEW to conduct the needs and resource assessment and prepare a County Epidemiological Assessment Report. The County Epidemiological Assessment Report data must be included in TPCC Final Evaluation Report.
  - 7. Develop a TPCC five year evaluation report that outlines and details outcomes and accomplishments for the TPCC comprehensive community-based tobacco prevention and control activities, including evidence-based prevention, enforcement, cessation, tobacco-related health disparities and secondhand smoke strategies. The purpose of the final evaluation is to provide the coalition and stakeholders with a summary report of activities, processes, and results, which allows the coalition to Recognize coalition achievements, including capacity gains and short- and long-term outcomes.
    - a. Acknowledge stakeholder's work over the five years of TCC funding
    - b. Identify approaches that worked, and devise steps to ensure they're used in the future.
    - c. Contractor must use the Final Evaluation Report template provided by the DSHS-funded statewide evaluation contractor. Contractor shall submit the TPCC Final Evaluation Report DRAFT by June 15, 2013
    - d. Submit TPCC Final Evaluation Report by August 15, 2013.
