We have the ability to provide full enforcement within Fort Bend County.

The Fort Bend County Sheriff's office received the Comptroller's Tobacco Compliance Grant for a number of years and always performed well above 100% in our tobacco prevention efforts. Our goal is to conduct controlled buys on 200% of the permitted retail outlets in our county. We have the determination to continue our ultimate goal of limiting minors' access to tobacco and, based on our experience, we know the retailer plays a huge role in that goal. It's very simple. If the retailers don't see, the minors won't have access. By making continued visits to the outlets and letting the retailers know we are serious about tobacco sales to minors, we hope to keep the buy rate in Fort Bend County low. From September 1, 2012 until April 16, 2013 we have conducted a total of 508 controlled buys with 17 sales to minors which is a 3.3% buy rate. Our plan is to conduct controlled buys on all tobacco permitted retailers in our county where minors have access and to make follow-up controlled buys on outlets that sell to minors as well as make buy attempts on those outlets that have a history of selling tobacco to minors.
