ADDENDUM 2 TO SERVICE AGREEMENT


- 1. The following LIFEPAK® CR Plus devices are added to the Agreement:

The Agreement is modified, amended and supplemented only to the extent set forth herein, and as so modified, amended and supplemented, shall remain in full force and effect between the Parties or their successor and assigns. In the event of any conflict between the provisions of this Amendment and those of the Agreement, the terms of this Amendment shall prevail; and
- 5. All capitalized terms used herein shall have the same meaning given to such terms in the Agreement unless otherwise indicated.
- 6. This Agreement may be executed by the Parties hereto individually or in any combination, in one or more counterparts, each of which shall be an original and all of which shall together constitute one and the same agreement. Signatures to this Agreement transmitted by facsimile transmission, by electronic mail in portable document format (".pdf") form, or by any other electronic means intended to preserve the original graphic and pictorial appearance of a document, Facsimile signatures will have the same force and binding effect as physical execution and delivery of the paper document bearing the original signature..
