

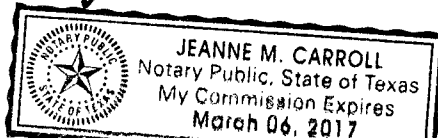

**NOTICE OF PUBLIC MEETING**

The Edward Byrne Memorial Justice Assistance Grant (JAG) Program (42 U.S.C. 3751(a)) is the primary provider of federal criminal justice funding to state and local jurisdictions. JAG funds support all components of the criminal justice system, from multi-jurisdictional drug and gang task forces to crime prevention and domestic violence programs, courts, corrections, treatment, and justice information sharing initiatives. JAG-funded projects may address crime through the provision of services directly to individuals and/or communities and by improving the effectiveness and efficiency of criminal justice systems, processes and procedures.

**A public meeting will be held on Tuesday, July 2, at 1:00 p.m., at the Fort Bend County Commissioners Court, 7<sup>th</sup> floor, William B. Travis Building, 301 Jackson, Richmond, Texas, to receive comments from the public regarding the allocation of the FY2013 Edward Byrne Memorial Justice Assistance Grant (JAG) application for funds in the amount of \$71,795.00.**

These funds may be used for local initiatives, technical assistance, training, personnel, equipment, supplies, contractual support, and criminal justice information systems for criminal justice that will improve or enhance such areas as: law enforcement programs, prosecution and court programs, prevention and education programs, corrections and community corrections programs, drug treatment and enforcement programs, planning, evaluation and technology improvement programs, crime victim and witness programs. The public is invited to attend and to submit comments to Commissioners Court. Comments will be incorporated into the draft FY2013 JAG application, as appropriate.
