

SHELTER PLUS CARE AMENDMENT AND EXTENSION AGREEMENT

This Amendment is made by and between the United States Department of Housing and Urban Development (HUD) and Fort Bend County, Texas (the Recipient), whose business address is 301 Jackson Street, Richmond, TX 77469 and whose Tax ID number is 74-6001969 for Shelter Plus Care Project Number TX24C700002.

RECITALS

1. HUD and Recipient entered into the Shelter Plus Care Agreement dated September 10, 2008 for Project number TX24C700002 located in Fort Bend County, Texas (the Grant Agreement).
2. Under the terms of the Grant Agreement, Recipient received a grant from HUD in the amount of \$1,062,600 to be used for Tenant-based rental assistance (TRA) as described in the Grant Agreement. The term of the Grant Agreement will end October 28, 2013.
3. Recipient has encountered difficulties in obtaining matching social services and in bringing in hard-to-reach homeless persons with chronic problems into permanent housing. These difficulties have impacted grant expenditures.
4. The need for housing assistance for hard-to-reach homeless persons with chronic problems continues within the jurisdiction within which the project is located.
5. The need for rental assistance continues.
6. HUD has reviewed the performance of the Recipient and has determined that the grant funds remaining at the end of the term should not be deobligated.
7. HUD and the Recipient desire to extend the term of the Grant.

AGREEMENTS

1. The Grant Agreement is hereby amended by extending the term for a period which ends twelve (12) months from the last day of the prior grant term, with the exception that if the grant is for TRA, Sponsor-based rental assistance (SRA), or Project-based rental assistance (PRA) without Rehab, the grant will end the earlier of that date or September 30, 2014. During the extended term the Recipient shall continue to carry out the activities described in the Grant Agreement. If all grant funds are expended for eligible program activities before the end of the additional term, the grant shall expire and the Recipient shall notify HUD in writing and request termination of this Grant Amendment and Extension Agreement. Pursuant to 31 USC 1552(a), for TRA, SRA, and PRA without Rehab component grants awarded in 2003 and after, the grant funds are only

available for expenditure until September 30, 2014, therefore the extended term will not extend beyond the availability of funds, or no later than September 30, 2014.


