## TERMINATION OF FIRST AMENDMENT TO TAX ABATEMENT AGREEMENT BETWEEN FORT BEND COUNTY AND CLB, INC., REINSTATEMENT OF ORIGINAL AGREEMENT

On November 22, 2011, a First Amendment to the Tax Abatement Agreement was made and entered into by and between FORT BEND COUNTY, TEXAS, CLB, INC., as "Owner," and CLB BUFFALO RUN, LLC, as "Assignee."

The tax abatement shall apply for the tax years as stated in the original Agreement and this reinstatement does not purport to extend the tax abatement to tax years beyond tax year 2022, as stated in the original agreement.


