ORDER APPOINTING DIRECTOR FOR  
FORT BEND COUNTY LEVEE IMPROVEMENT DISTRICT NO. 14

WHEREAS, the Commissioners Court of Fort Bend County, Texas, has heretofore appointed the Board of Directors of Fort Bend County Levee Improvement District No. 14 (the "District"); and

WHEREAS, the Commissioners Court reappointed Jeffrey Anderson, Herb Krog, and David Shaw to serve as Directors for the District for the lawful four-year term of office commencing effective July 2, 2012, and expiring on July 2, 2016, or until their successors shall be appointed and qualified; and

WHEREAS, David Shaw has resigned his position on the Board of Directors of the District effective as of the date the Commissioners Court of Fort Bend County, Texas, appoints a new director to serve for the remaining term; and

WHEREAS, the Commissioners Court of Fort Bend County, Texas, desires to appoint Sujeeth Draksharam, a resident of the District, to serve as Director for the District for the remaining term of office expiring July 2, 2016, or until his successor shall be appointed and qualified; and

WHEREAS, Sujeeth Draksharam is over twenty-one years of age, a resident citizen of the State of Texas, is otherwise qualified by law to serve as Directors of the District, and is not disqualified from serving as Directors of the District by reason of any law; and

WHEREAS, Title 4, Chapter 57 of the Texas Water Code, as amended, confers jurisdiction on the County Judge and Commissioners Court of Fort Bend County, Texas to appoint Directors of the District; Now Therefore,



Section 1: The foregoing recitals are hereby found to be true and correct.

Section 2: Sujeeth Draksharam is hereby appointed as Director of Fort Bend County Levee Improvement District No. 14 to serve in that capacity for the remaining term of office which expires on July 2, 2016, or until his successor shall be appointed and qualified.

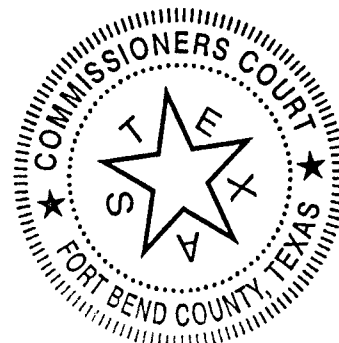

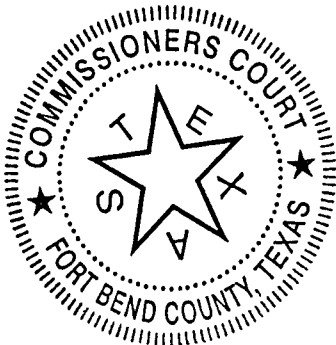
