RESOLUTION TO ABANDON AND CLOSE THOMPSON FERRY ROAD AND HAGERSON ROAD AT THE FOLLOWING LOCATIONS:

THOMPSON FERRY ROAD TO BE ABANDONED AND CLOSED FROM ITS INTERSECTION WITH KNIGHTS COURT TO ITS INTERSECTION WITH HAGERSON ROAD AT STEEP BANK CREEK, A DISTANCE OF APPROXIMATELY 3123 FEET, SAVE AND EXCEPT FOR THAT EXISTING SEGMENT OF THOMPSON FERRY ROAD EXTENDING FOR A DISTANCE OF APPROXIMATELY 649.25 FEET SOUTH FROM THE INTERSECTION OF THOMPSON FERRY ROAD AT CREEKSTONE VILLAGE DRIVE TO THE PROPERTY LINE OF FORT BEND COUNTY LEVY IMPROVEMENT DISTRICT NO.19'S LEVEE:

HAGERSON ROAD TO BE ABANDONED AND CLOSED FROM ITS INTERSECTION WITH THOMPSON FERRY ROAD AT STEEP BANK CREEK TO A POINT ENDING AT THE NORTHEAST CORNER OF A TWO ACRE CEMETERY OWNED BY THE BUSH FOUNDATION, INC., A DISTANCE OF APPROXIMATELY 2752 FEET, ALL LOCATED IN FORT BEND COUNTY, TEXAS

WHEREAS, Fort Bend County acquired THOMPSON FERRY ROAD and HAGERSON ROAD by prescriptive rights and accepted such roads into the county road log and maintenance system April 28, 1986; and,

WHEREAS, the segments of THOMPSON FERRY ROAD to be abandoned and closed run approximately 3123 feet to the south and southwest of its intersection with KNIGHTS COURT to its intersection with Hagerson Road at Steep Bank Creek; and,



WHEREAS that segment of Thompson Ferry Road extending from its intersection with Creekstone Village Drive and extending to the south for approximately 649.25 feet to the security gate and property line of Fort Bend County Levee Improvement District No. 19 is expressly excluded from this resolution and order of abandonment and closure; and,

WHEREAS, the segment of HAGERSON ROAD to be abandoned and closed runs approximately 917.94 feet to the northwest and then 1833.87 feet to the southwest from its intersection with Thompson Ferry Road at Steep Bank Creek, terminating at the property line of a 2 acre cemetery parcel owned by The Bush Foundation, Inc.; and,

WHEREAS, the replacement roads LJ Parkway, Creekstone Village Crossing Drive and Creekstone Crossing Drive are built and ready to accommodate the traffic; and

WHEREAS, those segments of THOMPSON FERRY ROAD and HAGERSON ROAD to be abandoned and closed are no longer needed, Fort Bend County desires to abandon and close same;

THEREFORE, on this date the Commissioners Court of Fort Bend County, Texas abandons and closes those segments of THOMPSON FERRY ROAD and HAGERSON ROAD, all as shown on the field notes and exhibits attached hereto as Exhibit A and Exhibit B.

FIELD NOTES FOR 7.91 ACRES

Being a 1.11 acre tract of land (Tract A) and a 6.80 acre tract of land (Tract B) located in the Elijah Roark Survey, A-77 and the William Little Survey, Abstract-54, in Fort Bend County, Texas; said 1.11 acre tract being a portion of Thompson Ferry Road (60-feet wide) as recorded in Volume K, Page 274 of the Commissioners Court Minutes of Fort Bend County, said 6.80 acre tract being a portion of said Thompson Ferry Road as recorded in Volume K, Page 274 of the Commissioners Court Minutes of Fort Bend County, a portion of Thompson Ferry Road as recorded in Clerk's File Number 2007136955 of the Official Records of Fort Bend County (O.R.F.B.C.), all of the portion of Hagerson Road recorded in Volume 138, Page 388 of the Fort Bend County Deed Records and a portion of Hagerson Road being a prescriptive Right-of-Way (R.O.W.); said tracts being more particularly described by metes and bounds as follows (all bearings are referenced to the City of Missouri City G.P.S. 





On this ____ day of Jaxiax 13, 2014, at a regular meeting of the Commissioners Court of Fort Bend County, Texas, sitting as the governing body Fort Bend County, Texas, upon motion of Commissioner seconded by Commissioner wever, duly put and carried, by unanimous vote,

Commissioners Court adopts the resolution to abandon and close segments of Thompson Ferry Road and Hagerson Road as more fully described herein and in the Resolution supporting this order.

The following segments of county roads are ordered abandoned and closed:

- (1) Thompson Ferry Road from its intersection with Knights Court to its intersection with Hagerson Road at Steep Bank Creek, save and except for that certain segment of Thompson Ferry Road running 649.25 feet south from Creekstone Village Drive and terminating at the boundary line of property owned by the Fort Bend County Levee Improvement District No. 19, on said levee;
- (2) Hagerson Road from its intersection with Thompson Ferry Road at Steep Bank Creek to a point terminating at the northeast corner of a 2 acre cemetery parcel owned by The Bush Foundation, Inc.

The names of each property owner who receives a conveyance under § 251.058, Texas Transportation Code, of the public road or segment of public road abandoned and closed pursuant to this order are: Fort Bend County Levee Improvement District No. 19, Herrin Ranch Development II, Inc., Perry Homes, LLC, Hillsboro Estates LLC, and Sugar Land Ranch Development II Corp.

The dimensions of the property conveyed and referenced herein are described in Exhibits A and B of the Resolution, incorporated herein for all purposes, and indexed by the County Clerk pursuant to § 251.058(b) of the Texas Transportation Code.

The County Clerk is ordered to index into the deed records of Fort Bend County in a manner that describes (a), the county conveying the property as grantor and (b), the property owner receiving the conveyance as grantee, all as provided for by § 251.058(b).

After due consideration, the Court finds that the above described roads have been replaced and the County's needs and that of the public interest would be better served if such above described roads are abandoned and closed, and the same are hereby abandoned and closed as county roads pursuant to Texas Transportation Code § 251.058(b) and § 251.051 and that this Order be hereby

filed in the Deed Records of Fort Bend County, Texas forthwith.
