ORDER ORGANIZING AND APPOINTING DIRECTORS FOR WEST FORT BEND WATER AUTHORITY

WHEREAS, the Texas Legislature created the West Fort Bend Water Authority pursuant to Senate Bill 1870, 83rd Legislative Session, codified by adding Chapter 8878 to the Texas Special District Local Laws; and

WHEREAS, the Commissioners' Court of Fort Bend County, Texas (the "Commissioners' Court") desires to organize the West Fort Bend Water Authority (the "Authority") and appoint its directors; and

WHEREAS, Chapter 8878 of the Texas Special District Local Laws Code, as amended, confers jurisdiction on the Commissioners' Court to appoint the Directors of the Authority pursuant to Section 8878.057, for each precinct with a population of less than 25,000; and

WHEREAS, according to the 2010 Census, the population for each of the five precincts within the Authority was less than 25,000; and

WHEREAS, the Commissioners' Court desires to appoint Jim Gammill to serve as a Director for Precinct 1 for the Authority for a term expiring May 15, 2016, or until his successor is appointed and qualified; and

WHEREAS, the Commissioners' Court desires to appoint Jeff Haley to serve as Director for Precinct 2 for the Authority for a term expiring May 15, 2014, or until his successor is appointed and qualified; and

WHEREAS, the Commissioners' Court desires to appoint Delbert Wendt to serve as Director for Precinct 3 for the Authority for a term expiring May 15, 2016, or until his successor is appointed and qualified; and

WHEREAS, the Commissioners' Court desires to appoint Roland Adamson to serve as Director for Precinct 4 for the Authority for a term expiring May 15, 2014, or until his successor is appointed and qualified; and

WHEREAS, the Commissioners' Court desires to appoint Jim Gonzales to serve as Director for Precinct 5 for the Authority for a term expiring May 15, 2016, or until his successor is appointed and qualified; and

WHEREAS, Jim Gammill, Jeff Haley, Delbert Wendt, Roland Adamson, and Jim Gonzales are over eighteen years of age, resident citizens Fort Bend County, Texas, and otherwise qualified by law to serve as Directors of the Authority, and not disqualified from serving as Directors of the Authority by reason of any law; Now, therefore,

IT IS THEREFORE ORDERED, ADJUDGED AND DECREED by the Commissioners' Court:

Section 1: That the foregoing recitals be and the same are hereby found to be true and correct and are incorporated herein by reference.

Section 2: That Jim Gammill be and hereby is appointed as the Director of Precinct 1 of the West Fort Bend Water Authority, to serve in that capacity for a term expiring May 15, 2016, or until his successor is appointed and qualified, commencing upon the date passed and adopted by Commissioners' Court.

Section 3: That Jeff Haley be and hereby is appointed as the Director of Precinct 2 of the West Fort Bend Water Authority, to serve in that capacity for a term expiring May 15, 2014, or until his successor is appointed and qualified, commencing upon the date passed and adopted by Commissioners' Court.

Section 4: That Delbert Wendt be and hereby is appointed as the Director of Precinct 3 of the West Fort Bend Water Authority, to serve in that capacity for a term expiring May 15, 2016, or until his successor is appointed and qualified, commencing upon the date passed and adopted by Commissioners' Court.

Section 5: That Roland Adamson be and hereby is appointed as the Director of Precinct 4 of the West Fort Bend Water Authority, to serve in that capacity for a term expiring May 15, 2014, or until his successor is appointed and qualified, commencing upon the date passed and adopted by Commissioners' Court.

Section 6: That Jim Gonzales be and hereby is appointed as the Director of Precinct 5 of the West Fort Bend Water Authority, to serve in that capacity for a term expiring May 15, 2016, or until his successor is appointed and qualified, commencing upon the date passed and adopted by Commissioners' Court.

Section 7: That a copy of the Order shall be recorded in the minutes of this Commissioners' Court.
