This letter shall confirm the requirements regarding provisions by the Cinco Ranch Residential Association II. Inc. to maintain the private streets in the above referenced subdivision in perpetuity.

Pursuant to the Fort Bend County Regulations of Subdivisions, as amended, and the approved plat, the above referenced subdivision assesses and collects an assessment from all property owners. The revenue generated from the assessment is used to cover specific operating expenses of the subdivision, as well as replacement expenses such as maintenance of private streets.
