ORDER APPOINTING JERRY W. BUSSELL
TEMPORARY JUSTICE OF THE PEACE, PRECINCT FOUR OF FORT BEND COUNTY

WHEREAS, Jim Richard is currently unable to preside as Justice of the Peace, Precinct Four of Fort Bend County;

WHEREAS, Texas Government Code §27.055 (b) authorizes the County Judge to appoint a temporary Justice of the Peace; and

WHEREAS, Jerry W. Bussell is qualified to serve as a Temporary Justice of the Peace per Texas Government Code §27.055 (e).

NOW, THEREFORE, as County Judge of Fort Bend County, I, Robert E. Hebert hereby appoint Jerry W. Bussell, as the temporary Justice of the Peace, Precinct Four, of Fort Bend County effective April 7, 2014, to serve during the absence of Judge Jim Richard and to be compensated by the day (or any fraction thereof) in an amount equal to the compensation of the regular justice. In accordance with Texas Government Code Section 27.055 (b), Jerry W. Bussell shall have all the rights and powers of the Justice of the Peace during this appointment but may not make personnel decisions about, or significant changes in, the Justice of the Peace's office.

This appointment shall expire upon notification to the County Judge that Judge Jim Richard is returning as Justice of the Peace Precinct Four of Fort Bend County.


