notice be placed on record according to the regulation order thereof.



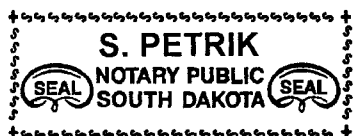


