WHEREAS, the Board of Directors of the District hereby requests that the Commissioners Court of Fort Bend County, Texas, appoint Justin R. Ring, Jared Jameson, and Stuart Rimes to the vacant positions to serve as director for the District for the term ending June 27, 2018, or until a successor shall be appointed and qualified; and

WHEREAS, Justin R. Ring, Jared Jameson, and Stuart Rimes are over twenty-one years of age, are residents citizen of Fort Bend County, and are otherwise qualified by law to serve as a director of the District; Now, Therefore;

Section 1: The Board of Directors hereby requests that the Commissioners Court of Fort Bend County, Texas, appoint Justin R. Ring, Jared Jameson, and Stuart Rimes as directors of the District for the lawful term of office, which expires on June 27, 2018.

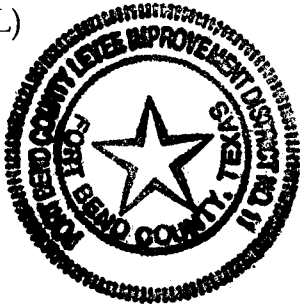

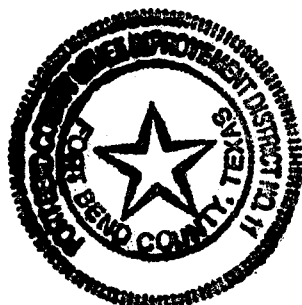

WHEREAS, the Commissioners Court of Fort Bend County, Texas ("Commissioners Court"), has heretofore appointed the Board of Directors of Fort Bend County Levee Improvement District No. 11 (the "District") to serve for lawful four-year terms of office expiring June 27, 2014; and

WHEREAS, Justin R. Ring, Stuart Rimes and Jared Jameson are the currently appointed resident directors of the District, who desire to be reappointed; and

WHEREAS, the Commissioners Court desires to appoint Justin R. Ring, Stuart Rimes and Jared Jameson to serve as Directors for the District for the term of office expiring June 27, 2018, or until his successor shall be appointed and qualified; and

WHEREAS, Justin R. Ring, Stuart Rimes and Jared Jameson are over twenty-one years of age, resident citizens of the State of Texas, are otherwise qualified by law to serve as a Directors of the District, and are not disqualified from serving as a Directors of the District by reason of any law; and
