The total dollar amount available shall be increased by \$6,850.00 to bring the total not to exceed amount to \$30,000 for the 2013-14 agreement term.
- 2. All terms and conditions of the Agreement and any addenda, not modified herein shall remain in full force and effect and for the term of Agreement. conflict between this Addendum and the Agreement, the provisions of this Addendum shall prevail.
