WHEREAS, the Commissioners Court of Fort Bend County, Texas, has heretofore appointed the Board of Directors of Fort Bend County Levee Improvement District No. 15 (the "District"), and approved the bonds and oaths of such Directors; and

WHEREAS, Director Dana Leared Koy submitted her resignation from the Board of Directors of the District; and

WHEREAS, the Commissioners Court of Fort Bend County, Texas, desires to appoint Terri Kurkjian to serve as a Director for the District as a replacement for Dana Leared Koy for the term of office expiring September 19, 2016 or until her successor shall be appointed and qualified; and

WHEREAS, the sworn statement and the bond and oath of office of Terri Kurkjian are in proper form, have been properly executed, and are hereby approved by the County Judge and Commissioners Court of Fort Bend County, Texas; and

WHEREAS, Terri Kurkjian is over twenty-one years of age, a resident citizen of the State of Texas, otherwise qualified by law to serve as a Director of the District, and not disqualified from serving as a Director of the District by reason of any law; and

WHEREAS, Title 4, Chapter 57 of the Texas Water Code, as amended, confers jurisdiction on the County Judge and Commissioners Court of Fort Bend County, Texas to appoint the Director of the District and approve her sworn statement and her bond and oath; now therefore,

IT IS THEREFORE ORDERED, ADJUDGED AND DECREED by the County Judge and Commissioners Court of Fort Bend County, Texas that:


Section 1: The foregoing recitals be and the same are hereby found to be true and correct.

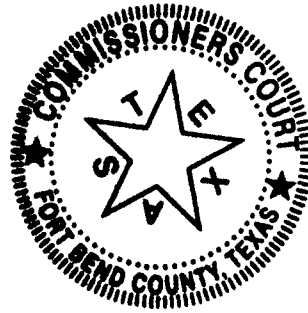

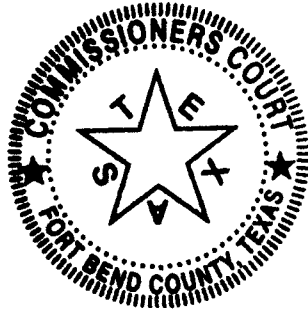
