4th ADDENDUM TO AGREEMENT BETWEEN FORT BEND COUNTY AND
JESSE A. REED III, PHD DBA AWARE/AWARE, INC.

THIS ADDENDUM is made and entered into by and between **FORT BEND COUNTY**, (hereinafter referred to as "County"), a body corporate and politic," and **JESSE A. REED III, PHD DBA AWARE/AWARE, INC.** hereinafter referred to as "Contractor," authorized to conduct business in the State of Texas.

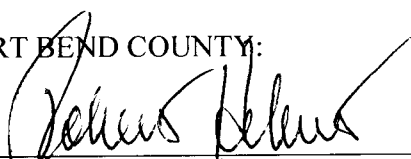
WHEREAS, the parties have executed and accepted that certain **AGREEMENT BETWEEN FORT BEND COUNTY AND JESSE A. REED DBA AWARE/AWARE, INC.** executed by County on or about March 23, 2012; first amended on or about December 18, 2012 which was also amended on or about February 25, 2014 and amended last on June 26, 2014; and

WHEREAS, the following changes are incorporated as if a part of the original Agreement incorporated by reference in the same as if fully set forth verbatim herein:

1. Effective upon signature of County, the flat rate per prospective employee profile specified in Section 4.02 shall not exceed **\$200.00**, per profile. The total dollar amount available shall be increased by \$2,450.00 to bring the total not to exceed amount to \$32,450.00 for the 2013-14 agreement term.
2. All terms and conditions of the Agreement and any addenda, not modified herein shall remain in full force and effect and for the term of Agreement. If there is a conflict between this Addendum and the Agreement, the provisions of this Addendum shall prevail.
