TO: Seventy Seven Thousand Two Hundred Eighty Eight Dollars and 00/100 (\$77,288.00)

The Decrease of said bond penalty shall be effective as of the 17th day of September, 2014, and does hereby agree that the continuity of protection under said bond subject to changes in penalty shall not be impaired hereby, provided that the aggregate liability of the above mentioned bond shall not exceed the amount of liability assumed by it at the time the act and/or acts of default were committed and in no event shall such liability be cumulative.
