Paul Stamatis Jr.**

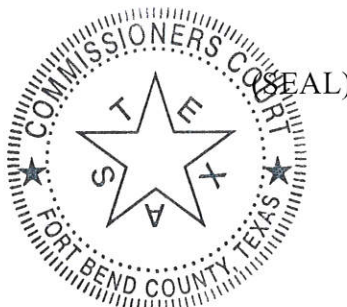

# Conservation and Reclamation Districts Election Ballot

## 2016-2017 Candidate for Board of Directors Fort Bend Central Appraisal District

**Jurisdiction: Fort Bend County Drainage District**

**Vote Entitlement: 37**

Section 6.03 of the Texas Property Tax Code requires five directors to be appointed by the taxing units that participate in the district as provided by this section. Each conservation and reclamation district entitled to vote may nominate by resolution adopted by its governing body one candidate for the district's board of directors. The names of the district's nominees submitted to the chief appraiser are:

Cast your vote(s) above for the candidate(s) of your choice and return the ballot along with the resolution of the vote, to the Fort Bend Central Appraisal District before August 15, 2015.

The nominee with the most votes is the nominee of the conservation and reclamation districts in the upcoming appraisal district board of director's election, if the nominee received more than 10 percent of the votes entitled to be cast by all of the conservation and reclamation districts in the appraisal district. The nominee shall be named on the ballot with the candidates nominated by the other voting taxing units. The chief appraiser shall resolve a tie vote by any method of chance.
