bond covering all such cable, conduit and/or pole line activity;

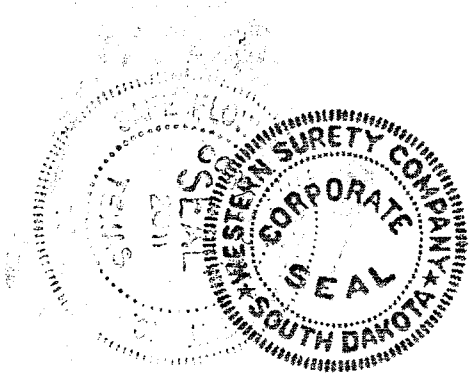
NOW, THEREFORE, if the above bounden principal shall faithfully perform all its cable,
