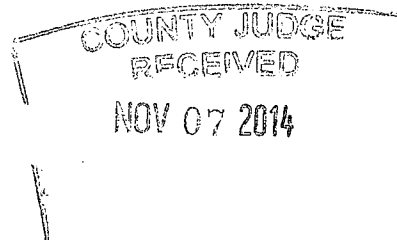

COMES NOW, the undersigned Petitioners, all being qualified voters who own taxable real property within the boundaries of Fort Bend County and being specifically within the areas and boundaries of this proposed Emergency Services District as hereinafter described, who hereby respectfully present unto this Court their Petition for the creation and operation of an Emergency Services District in Fort Bend County, Texas, and ask this Court to receive and act upon the same, and as reason therefore would show unto this Honorable Court as follows:

I.

That such an Emergency Services District is to be organized in Fort Bend County, State of Texas, and that the District is to be created and is to operate under Article III, Section 48-e, Texas Constitution, and Chapter 775, Health and Human Safety Code, including having the power to levy and collect taxes of ten cents (\$.10) on each \$100 of the taxable value of property taxable by the District; and the District will be so created and operated to protect life and health and as so provided in said Constitution and Legislative Act, as amended.

II.

That the name of the proposed District shall be "FORT BEND COUNTY EMERGENCY SERVICES DISTRICT NO. 7" and shall be located in a portion of Fort Bend County, Texas.

III.

That this Petition presented to the County Judge of Fort Bend County, Texas for the creation of "FORT BEND COUNTY EMERGENCY SERVICES DISTRICT NO. 7" is signed by not less than ONE HUNDRED (100) qualified
