Re: Request for reconsideration of denial of consent to creation of Fort Bend County Emergency Services District No. 7 (Pecan Grove VFD Service Area)

Dear Mayor Moore:

You may re-call that this office is counsel to the petitioners who are seeking to create an Emergency Services District ("ESD") in the Pecan Grove and Waterside Estates areas of Fort Bend County. The proposed District boundaries include portions of the ETJ of the City of Richmond.

I would like to follow-up the December 15, 2014 City Council meeting when the Council voted to deny the Petitioners' request for consent to include a part of the Richmond ETJ in the proposed ESD. This action was later memorialized in a January 5, 2015 letter.

We of course respect the Council's right and prerogative to make that decision. However, I would like to address again one point that perhaps was not made as clearly as possible at the December 15 meeting. This concerns the City's annexation rights and ability to retain control of its ETJ area.

The following is the applicable language from Section 775.022, Health & Safety Code, concerning municipal annexation.

(a) If a municipality completes all other procedures necessary to annex territory in a district and if the municipality intends to provide emergency services to the territory by the use of municipal personnel or by some method other than by use of the district, the municipality shall send written notice of that fact to the board. The municipality must send the notice to the secretary of the board by certified mail, return receipt requested. The territory remains part of the district and does not become part of the municipality until the secretary of the board receives the notice. On receipt of the notice, the board shall immediately change its records to

show that the territory has been disannexed from the district and shall cease to provide further services to the residents of that territory.

The existence of an ESD does not in any way preclude municipal annexation. In fact the annexation of only part of an ESD is contemplated under the section.

The section also provides:

(c) If a municipality annexes territory in a district, the municipality shall compensate the district immediately after disannexation of the territory under Subsection (a) in an amount equal to the annexed territory's pro rata share of the district's bonded and other indebtedness as computed according to the formula in Subsection (e). The district shall apply compensation received from a municipality under this subsection exclusively to the payment of the annexed territory's pro rata share of the district's bonded and other indebtedness.

As you can see, in the event of any debt, a municipal payment is only for a pro rata portion. This contrasts significantly from an annexation of a MUD, where partial annexations are not permitted and all the MUD debt must be accounted for.

Going even further, the annexation by a city of a portion of an ESD does not even impose the requirement of the city taking on the debt payment or any obligation to provide emergency services. It is the city's option. As cited in Section 775.022(a), the municipal obligations are only triggered upon the city's election. The section provides municipal undertaking only "... if the municipality intends to provide emergency services to the territory by the use of municipal personnel or by some method other than by use of the district ..."

We truly feel that your granting of the consent would allow the residents in the proposed ESD to benefit without in any way either stifling the City's growth options or placing any real burdens on the City by creation of the proposed ESD.

On behalf of the Petitioners, I would respectfully request for a City Council agenda item for the City's January regular meeting to reconsider the December 15, 2014 decision to deny the request for municipal consent for the ESD.

The petition representatives and I will be happy to confer in furtherance of our request.
