



WHEREAS, the Commissioners Court desires to appoint Rodney Vannerson and Michael Ross to serve as Directors for the District for the four-year term of office expiring January 25, 2019, or until his successor shall be appointed and qualified; and

WHEREAS, Rodney Vannerson and Michael Ross are over twenty-one years of age, resident citizens of the State of Texas, are otherwise qualified by law to serve as a Director of the District, and are not disqualified from serving as a Director of the District by reason of any law; and




