Commissioner Meyers stated that with concurrence to Brazoria County we create the Brazoria and Fort Bend Rail District and appoint as our directors of Fort Bend County Michael Siwierka and Frank Hester. Commissioner Patterson questioned if the district would have taxing authority or would revenue come from the general fund. Commissioner Morrison stated that the Rail District does not have taxing authority. It has a revenue raising authority through options like selling revenue bonds, similar to a toll road. Judge Hebert commented that it could not levee a sales or property tax. Commissioner Meyers stated that it would be fee based revenue. Marcus Spencer, Assistant County Attorney, mentioned that he is uncertain about the revenue bonds because you have to pay back the debt on the bonds. The use is prohibited from lowering taxes, but has revenue source for the use of the rail district. It acts as contract power. If you had to get the property you would have to fund it somehow and it would come from the County fund. Judge Hebert stated for the record we have had a rail authority that has been in existence since 1998 along this same right of way. We dissolved that one, because according to the County Attorney, it was easier than to create a new one under the law than to try and go back and update and fix the existing one because no work had been done. This is a recreation, reauthorization of a new rural rail district. The bottom line is that the new rural rail district cannot lower a tax nor can it levee a sales tax. It will generate third party revenue.
