Subject: RFI No. 001 - West Bellfort Waterline Adjustment

Mr. Slawinski,

The existing 12" waterline at the intersection of West Bellfort and Jacksonville Lake is in conflict with the proposed 24" storm drain line at approximately station 70+55 (see attached drawing), and will need to be adjusted. It is my understanding after speaking to Ms. Kathy Bender of Jacobs Engineering, that the waterline will need to be lowered below the existing 24" NFBWA waterline in steel casing and utilizing restrained joint carrier pipe. Due to the depth of the line, there is a fire hydrant assembly south of West Bellfort and west of Jacksonville Lake that will need to be removed and reinstalled along with sidewalks. I need someone to approve the scope of work (and provide a sketch if possible) as well as our proposal for the lump sum of \$41,100.00. Please don't hesitate to call me if you have any questions, thanks.
