

Theodore Andrews, Chairman of the Taxing Increment Reinvestment Zone Number Twenty Five, is in favor of #26B.

Commissioner Prestage had a presentation on "A Tribute To Thomas Lane Taylor". Thomas Lane Taylor was a history maker who left a legacy in area communities of a man "who will protect, preserve and promote our heritage." He was the first black, Fort Bend County Commissioner for Precinct 2, from 1878-1882. During the Jaybird-Woodpecker War, there was a debate whether African-Americans ought to have an opportunity to participate in politics. Mr. Tom Taylor resisted eviction from Fort Bend County; but under great duress, he eventually moved his family to Wharton County. This family has lived in and around the community of Hungerford for 100 years or more and has contributed to the development of this community. In 1986, Wharton County Historical Commission celebrated Mr. Taylor and his family. In February 2015, the City of Missouri City saluted Taylor's success by renaming a portion of Lexington Boulevard to "Thomas Taylor Parkway." Today, Sgt Erel Taylor a great-grandson of Mr. Taylor's serves with the Fort Bend County Sherriff's office and helped present a portrait of Commissioner Thomas Lane Taylor. This portrait will be placed in the Fort Bend County Historic Courthouse.
