(Looking North/West)

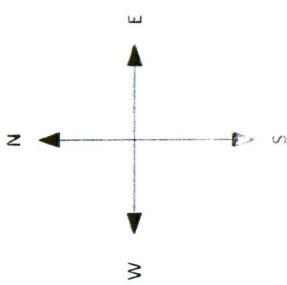

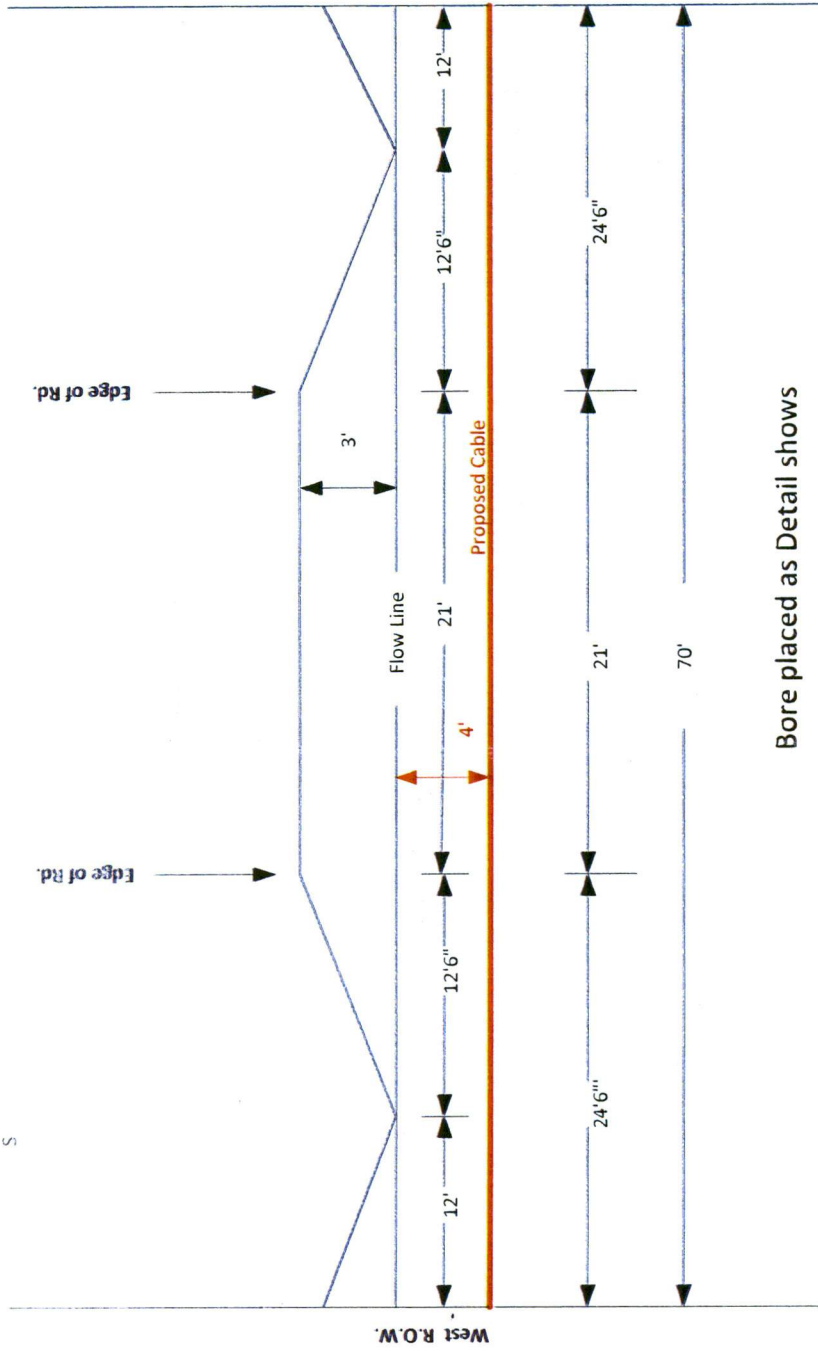
