AMENDMENT # 1

THIS AMENDMENT is made by and between the State of Texas, acting through the Texas Department of Transportation, called the "State", and Fort Bend County, acting by and through its duly authorized officials, called the "Local Government."

WITNESSETH

WHEREAS, the State and the Local Government executed an agreement on March 12th, 2012; and,

WHEREAS, it has become necessary to amend that agreement due to the Local Government's request to include culvert pipes to provide access to channel banks;

NOW THEREFORE, in consideration of the premises and of the mutual covenants and agreements of the parties, the State and the Local Government do agree as follows:

A G R E E M E N T

1. Description of Amended Items

Attachment D, Estimate of Direct Costs, is deleted in its entirety and replaced with Attachment D-1, Estimate of Direct State Costs.

2. All other provisions of the original contract are unchanged and remain in full force and effect.

3. Signatory Warranty
