- 2) Draft Certificate for Order regarding the minutes of the Commissioners Court meeting.

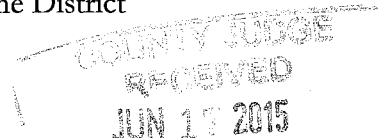

WHEREAS, the Commissioners Court of Fort Bend County, Texas, has heretofore appointed Kendall Beckman, John P. "Bucky" Richardson, and Michael L. Johnson as Directors of Sienna Plantation Levee Improvement District of Fort Bend County, Texas (the "District"), for terms that commenced on July 20, 2011 and expire on July 20, 2015, respectively; and

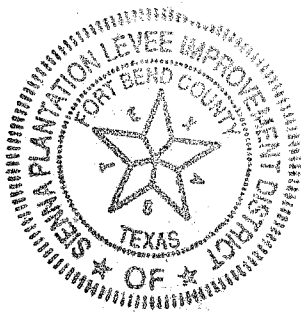

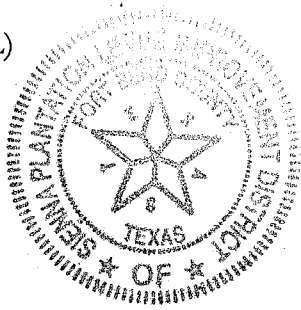


