ORDER OF FORT BEND COUNTY TO CREATE FORT BEND COUNTY EMERGENCY SERVICES DISTRICT NO. 6 IN PRECINCT 1 AND THE LEVY BY SAID DISTRICT OF A TAX NOT TO EXCEED TEN (10) CENTS ON THE ONE HUNDRED DOLLAR (\$100.00) VALUATION AFTER AN AFFIRMATIVE VOTE OF THE MAJORITY OF THE VOTES CAST IN THE SPECIAL ISSUE ELECTION HELD ON MAY 9, 2015, FAVORED CREATION OF THE DISTRICT AS REQUIRED BY SECTION 775.019 AND OTHER RELEVANT PROVISIONS OF CHAPTER 775, TEXAS HEALTH & SAFETY CODE

WHEREAS, at an election held on the 9th day of May, 2015, in that part of Fort Bend County, State of Texas, described with the applicable boundaries attached hereto and incorporated herein as Exhibit A, "Boundaries of the Fort Bend County Emergency Services District No. 6";

WHEREAS, at this above described election, there was submitted to the qualified voters the question of whether the territory should be formed into and emergency services district under state law; and


WHEREAS, at the election 143 votes were cast in favor of formation of the district and 28 votes were cast against formation; and

WHEREAS, the formation of the emergency services district received the affirmative vote of the majority of the votes cast at the election as provided by law;

THEREFORE, BE IT ORDERED, ADJUDGED, AND DECREED BY THE COMMISSIONERS COURT OF FORT BEND COUNTY, TEXAS THAT THE TRACT DESCRIBED ABOVE IN THIS ORDER HAS BEEN DULY AND LEGALLY FORMED INTO AN EMERGENCY SERVICES DISTRICT UNDER THE NAME OF "FORT BEND COUNTY EMERGENCY SERVICES DISTRICT NO. 6", UNDER ARTICLE III, SECTION 48-e, OF THE TEXAS CONSTITUTION AS PROPOSED BY S.J.R. NO. 27, ACTS OF THE 70TH LEGISLATURE, REGULAR SESSION 1987, AND ADOPTED BY THE VOTERS AT AN ELECTION HELD NOVEMBER 3, 1987, AND HAS THE POWERS VESTED BY LAW IN THE DISTRICT.


