3. This permit expires one (1) year from date of permit if construction has not commenced.

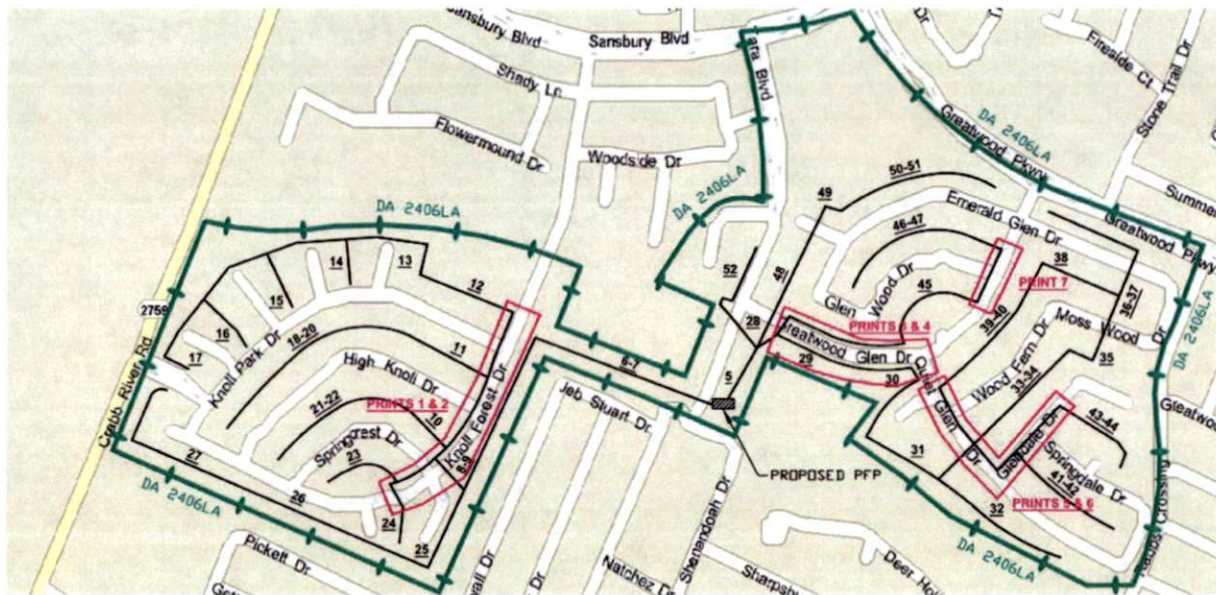
