AMENDMENT NUMBER 2

Pursuant to Article 1 (CONTRACT PERIOD) and Article 9 (AMENDMENTS) in the General Terms and Conditions of the Agreement, TCEQ and Fort Bend County (GRANTEE) agree to amend Contract Number 582-12-20281 to extend the Expiration Date of the Agreement from 08/31/2015 to 08/31/2017 and to add \$1,456,648.00 in funding for Fiscal Years 2016 and 2017, bringing the total Maximum TCEQ Obligation to \$3,608,616.00.


