ADDENDUM TO RIGHT OF WAY SERVICES AGREEMENT

THIS ADDENDUM, is made and entered into by and between Fort Bend County (hereinafter "County"), a body corporate and politic under the laws of the State of Texas, and Property Acquisition Services, LLC, (hereinafter "Contractor"), a company authorized to conduct business in the State of Texas.

WHEREAS, the parties executed and accepted that certain Right of Way Services Agreement for Professional Property Acquisition Services effective February 24, 2004, (hereinafter "Agreement"); and

WHEREAS, the parties amended the Agreement for additional services to be provided and increase the total Maximum Compensation under the Subsequent Addendums (defined hereinafter):

- Effective November 22, 2005;
- Effective September 26, 2006;
- Effective June 12, 2007;
- Effective February 12, 2007;
- Effective March 3, 2009;
- Effective February 8, 2011; and
- Effective February 24, 2015

WHEREAS, the parties desire to further amend the Agreement for additional services to be provided and increase the total Maximum Compensation to complete the additional Services.

NOW, THEREFORE, the parties do mutually agree as follows:


1. County shall pay Contractor an additional one hundred seventeen thousand one hundred eighty-five dollars and no/100 (\$117,185.00) for the additional hours necessary to complete the additional property acquisition services to be rendered as described in Exhibit "A" attached hereto and incorporated herein for all purposes.
2. The Maximum Compensation payable to Contractor for Services rendered is hereby increased to an amount not to exceed two million ninety-two thousand one hundred eighty-five dollars and no/100 (\$2,092,185.00), authorized as follows:

\$250,000.00	Agreement effective February 24, 2004
\$100,000.00	Addendum effective November 22, 2005
\$150,000.00	Addendum effective September 26, 2006
\$100,000.00	Addendum effective June 12, 2007
\$250,000.00	Addendum effective February 12, 2008
\$500,000.00	Addendum effective March 3, 2009
\$500,000.00	Addendum effective February 8, 2011
\$125,000.00	Addendum effective February 25, 2015; and
\$117,185.00	This Addendum


3. In no case shall the amount paid by County for all Services under the Agreement and this Amendment exceed the Maximum Compensation without an approved change order.

Except as provided herein, all terms and conditions of the Agreement shall remain unchanged.

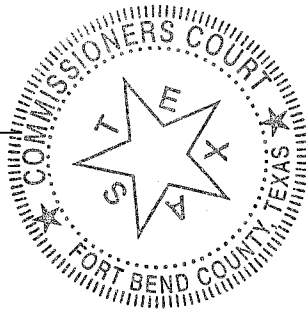




