

Whereupon, among other business the following was transacted at said meeting: a written order entitled:

ORDER APPOINTING DIRECTORS OF FORT BEND COUNTY

(the "Order") was duly introduced for the consideration of the Commissioners Court and reviewed in full. It was then duly moved by Commissioner Morrison and seconded by Commissioner Patterson that the Order be passed; and, after due discussion, the motion, carrying with it the passage of the Order, prevailed and carried by the following vote:

ORDER APPOINTING DIRECTORS OF

WHEREAS, the Fort Bend County Toll Road Authority (the "Authority") was duly created and its Board of Directors organized; and

WHEREAS, the Articles of Incorporation of the Authority were approved by the Fort Bend County Commissioners Court and have been filed with the Secretary of State of Texas; and

WHEREAS, pursuant to the Articles of Incorporation of the Authority five members were appointed to serve on the Board of Directors of the Authority; and

WHEREAS, the Commissioners Court of Fort Bend County, Texas desires to appoint [James D. Condrey, Bobbie A. Tallas, Charles Rencher, William D. Kee, III and Dean Hrbacek] to serve on the Board of Directors of the Authority from January 22, 2016 to January 22, 2020 or until their successors shall be appointed and qualified; and


WHEREAS, [James D. Condrey, Bobbie A. Tallas, Charles Rencher, William D. Kee, III and Dean Hrbacek] are over twenty-one years of age, resident citizens of the State of Texas, otherwise qualified by law to serve as Directors of the Authority, and not disqualified from serving as Directors of the Authority by any reason of law;

BE IT RESOLVED BY THE FORT BEND COUNTY COMMISSIONERS COURT THAT:

Section 1. [James D. Condrey, Bobbie A. Tallas, Charles Rencher, William D. Kee, III and Dean Hrbacek] are hereby appointed as Directors of Fort Bend County Toll Road Authority to serve in that capacity until January 22, 2020, or until their successors shall be appointed and qualified.

Section 2. A copy of the Order shall be recorded in the minutes of this Court.

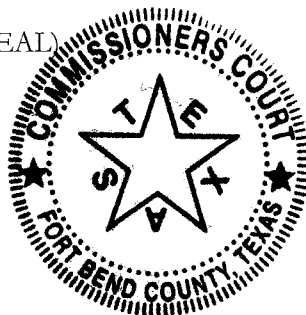



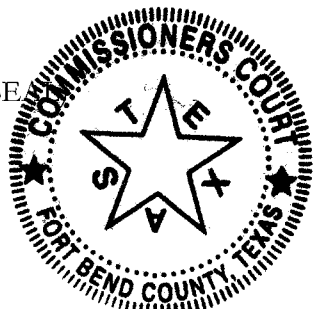
