Dear Commissioner Morrison:

The Fort Bend County Engineering Department has received a letter from the City of Rosenberg, regarding Ordinance No. 2015-38 providing for the disannexation of the Spacek Tract located between FM 2977 and Spacek Road. (a.k.a. Blume Addition). The tract consists of 81.1 acres located in the Robert Handy Survey, Abstract 187, Fort Bend County, Texas.

Due to the disannexation, the roads, revert back to the County for maintenance. The roads and mileage calculations are as follows:

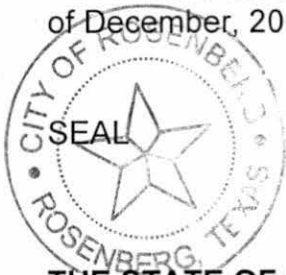

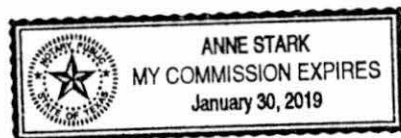
