**THIRD AMENDMENT TO
PROFESSIONAL ENGINEERING SERVICES AGREEMENT
FOR TURN LANE DESIGN IMPROVEMENTS
CONGESTION MITIGATION – Mobility Project X23
FORT BEND COUNTY ASSISTANCE DISTRICT NO. 1**

THIS THIRD AMENDMENT is made and entered into by and between Fort Bend County, Texas, a public body corporate and politic of the State of Texas, acting herein by and through its Commissioners Court, hereinafter “County,” Fort Bend County Assistance District No. 1, a public body corporate and politic of the State of Texas, acting herein by and through its Board of Directors, hereinafter “CAD No. 1,” and Progressive Consulting Engineers, PLLC, hereinafter referred to as “Engineer,” authorized to conduct business in the State of Texas, collectively referred to herein as the “Parties,” and

WHEREAS, the Parties entered an Agreement for Professional Engineering Services for roadway turn lane improvements at six (6) intersections: Fry Road at Seven Meadows Blvd., Fry Road at Grand Parkway (SH 99), S-Concrete Curve at the Whole Foods Market Driveway, Westheimer Parkway at Grand Parkway (SH 99), Westheimer Parkway at Cinco Ranch Blvd., and Westheimer Parkway at Commercial Center Drive, located in Fort Bend County, Texas, hereinafter referred to as the “Project;” dated December 18, 2012, hereinafter referred to as the “Agreement;” and

WHEREAS, the Parties entered into the First Amendment to the Agreement for Professional Engineering Services, dated May 30, 2013, hereinafter referred to as the “First Amendment”, and the Second Amendment to the Agreement for Professional Engineering Services, dated May 13, 2014, hereinafter referred to as the “Second Amendment” to memorialize modifications to the services necessary to complete the Project; and

WHEREAS, County, CAD No. 1 and Engineer desire to further amend said Agreement for additional services to be provided and increase the total maximum compensation to complete the additional services.

NOW, THEREFORE, in consideration of the foregoing, the Agreement between County, CAD No. 1 and Engineer is hereby amended as follows:

- A. Services to be rendered under the Agreement shall be amended to add construction support services for the Project, as described in the Proposal dated December 9, 2015, attached hereto as Exhibit A, incorporated herein for all purposes.
- B. Engineer’s compensation for the Project shall not exceed \$215,968.00; which includes an increase of \$39,300.00 for the additional services added under the First Amendment, a reduction of \$307.00 under the Second Amendment, and an

additional \$10,000.00 under this Third Amendment from the original not to exceed amount of \$166,975.00 under the Agreement.

- C. This Third Amendment shall extend the Time of Performance under the Agreement to expire on December 1, 2016.
- D. No additional funding shall be available for services provided under the Agreement without prior written consent of County.
- E. Except as modified herein, the Agreement, the First Amendment, and the Second Amendment remain in full force and effect and has not been modified or amended.
- F. If there is a conflict between this Third Amendment, the Agreement and prior amendments, the provisions of this Third Amendment shall prevail.

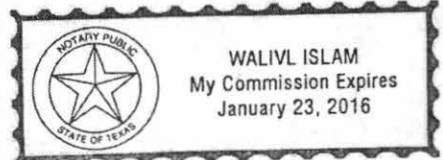
