**AMENDMENT TO AGREEMENT FOR  
 PROFESSIONAL ENGINEERING SERVICES**

**THIS AMENDMENT**, is made and entered into by and between Fort Bend County (hereinafter "County"), a body corporate and politic under the laws of the State of Texas, and IDC, Inc., (hereinafter "Contractor"), a company authorized to conduct business in the State of Texas.

WHEREAS, the parties executed and accepted that certain Agreement for Professional Engineering Services on February 24, 2015, (hereinafter "Agreement"); and

WHEREAS, the parties desire to amend the Agreement for additional services to be provided and increase the total Maximum Compensation for the completion of such additional services.

**NOW, THEREFORE**, the parties do mutually agree as follows:

1. County shall pay Contractor an additional fifteen thousand eight hundred fifty-five dollars and no/100 (\$15,855.00) for the additional engineering services as described in the proposal attached hereto as Exhibit "A" and incorporated herein for all purposes.
2. The Maximum Compensation payable to Contractor for Services rendered is hereby increased to an amount not to exceed three hundred fifty-two thousand one hundred thirty-nine dollars and no/100 (\$352,139.00), authorized as follows:
  - \$336,284.00 under the Agreement; and
  - \$15,855.00 under this Amendment.
3. In no case shall the amount paid by County for all Services under the Agreement and this Amendment exceed the Maximum Compensation without an approved change order.

Except as provided herein, all terms and conditions of the Agreement shall remain unchanged.

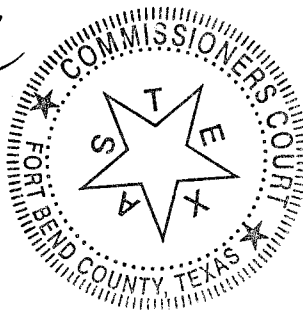

Per your request I have reviewed your proposed drainage easement parcel location. In order to obtain cross-section data within the proposed area, it will be necessary to extend our existing survey control and clear brush for approximately 800 linear feet past our current limits of brush clearing. The newly obtained cross-section data will line up with our recently submitted cross-section data, in order to properly extend the digital terrain model within the additional work area.

Submittal documents will include updating the existing 2D and 3D DGN Microstation drawings, along with updating the existing point ASCII file.

The Professional Services mentioned herein shall be completed for a lump sum cost of \$5,250.00 and can be completed within ten (10) business days from the date of approval.

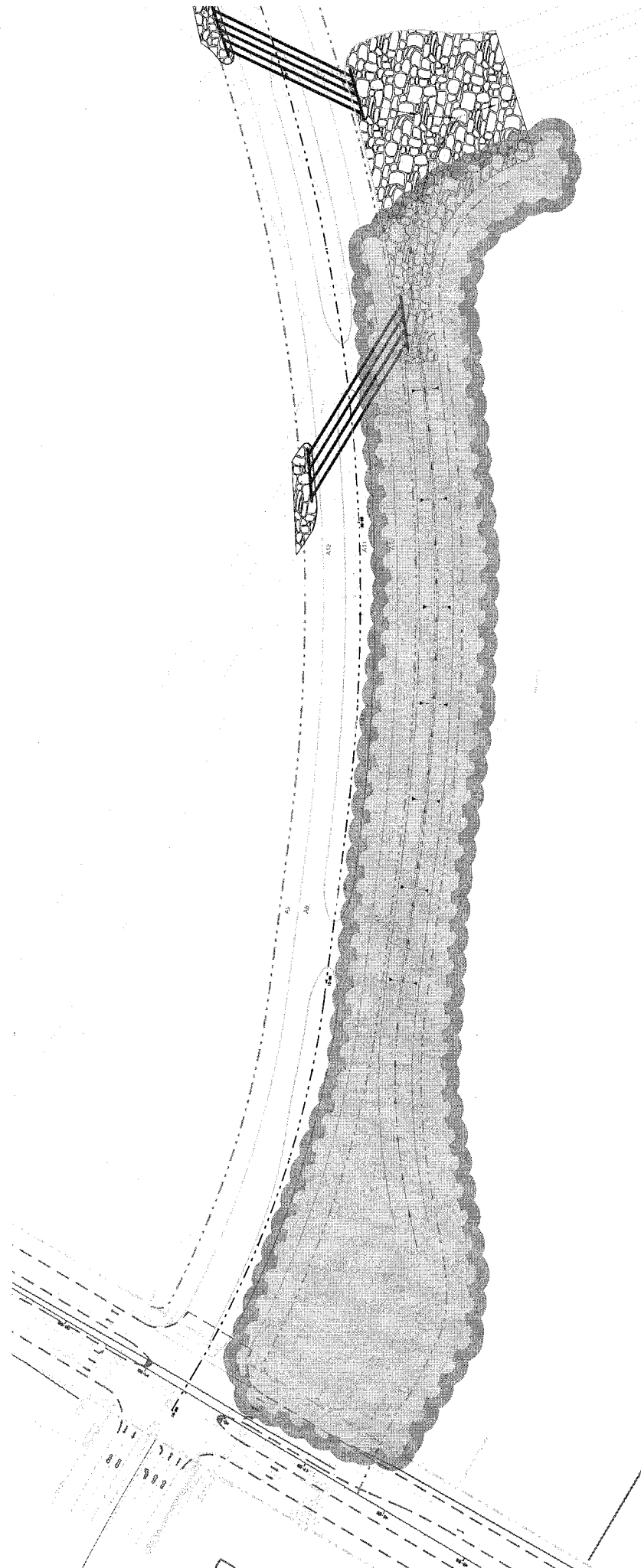
