Lt Cempa, Sgt Hill,

As you both are aware we have been having troubles with the server that is used for the storage of "in vehicle audio and video storage". It has been determined that a component described as a "raid controller" had failed. The raid controller was bypassed temporarily and the server is now working. Dell Computers has provided a new raid controller board as no charge since the server is still under warranty until January 10, 2018.

The raid controller is used when a computer has two internal hard drives. Currently this server only has one internal hard drive. And as it sits there is actually no need for a raid controller.

It is my recommendation that the new raid controller be installed, and a second internal hard drive be purchased and installed. This will create a system that will automatically create a backup of the primary hard drive on the secondary hard drive in the event that there is a failure. This will prevent the loss of any audio or video that may be required as evidence for prosecution.

The following information has been provided by Dell Computers so that we may purchase the identical hard drive that is currently installed in the server.
