

ASSIGNMENT AND CONSENT AGREEMENT

This Assignment and Consent Agreement (the "Agreement") is made and executed effective as hereinafter stated by and between Fort Bend County, (the "Client") and LJA Engineering, Inc., a Texas corporation providing professional engineering services ("LJA").

RECITALS

- A. Client and Carroll & Blackman, Inc. Consulting Engineers ("CBI") executed that certain agreement for professional engineering services, related to stormwater management program implementation services, titled "Agreement for Professional Engineering Services" on or about the 4th day of November, 2014 (the "Contract");
- B. CBI merged with LJA becoming the successor interest by merger to CBI on or about January 7, 2016;
- C. CBI wishes to assign the Contract to LJA pursuant to the merger;
- D. Client consents to the assignment of the Contract.
- E. Client, CBI and LJA acknowledge and agree that except for the assignment as herein provided, all other terms, conditions, obligations and payments due under the Contract are ratified and affirmed.

NOW, THEREFORE, for and in consideration of the mutual covenants herein contained and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties agree as follows;

ASSIGNMENT

CBI hereby assigns, transfers and conveys all of its rights, obligations, title, interest and liabilities in and to the Contract to LJA. LJA hereby accepts such assignment and assumes all of CBI's rights, obligations, title, and liabilities in and to the Contract, whether such rights, obligations, title, interest or liabilities arose before or after the date of this Agreement.

CONSENT TO ASSIGNMENT

Client hereby consents to the assignment of the Contract from CBI to LJA and agrees to look solely to LJA for the continued performance of the Contract from and after the date of the execution of this Agreement.


