

**SUPPLEMENTAL AGREEMENT NO. 4
TO
AGREEMENT OF DECEMBER 19, 2012
FOR TOLL SYSTEMS OPERATION AND MAINTENANCE AGREEMENT**

THIS SUPPLEMENTAL AGREEMENT is made and entered into this 23rd day of March, 2016, and modifies the TOLL SYSTEM OPERATIONS AND MAINTENANCE AGREEMENT effective December 19, 2012 (the "Agreement"), by and between the Fort Bend Grand Parkway Toll Road Authority (the "Authority"), a Texas Local Government Corporation, and TransCore, LP (the "Contractor"), a limited partnership organized under the laws of the State of Delaware.

The Agreement is hereby modified as follows:

1. In accordance with Section 1.02 of the Agreement, the Authority and Contractor approve the addition of services evidenced by the proposal attached as **Attachment 4** to this Supplemental Agreement.


This Supplemental Agreement does not alter, modify, or otherwise change any part of the Agreement, except as specifically stated in this Supplemental Agreement.

**ATTACHMENT 4
SCOPE OF WORK & COMPENSATION
FOR THIRD PARTY OCR IMPLEMENTATION**

TransCore has decided that the best third party OCR solution to add to the current Fort Bend system is the Carmen FreeFlow LPR OCR engine. The Carmen FreeFlow software licensing is based on the Server/Processor the software is running on. The servers we are running are quad core processors so we need quad core LPR OCR software runtime licenses. We will have to add their Carmen PCI express card config .173 to each of the servers as well.

The way we will need to configure this for the Fort Bend system is by roadway (at the Plaza level) so (3) licenses and (3) PCI cards. The PCI card is required because it is what Carmen uses to enforce licensing compliance.

TransCore is also recommending that we modify the Infinity PPS database processes to switch from using Infinity IRE for majority voting logic, to using the majority voting logic we developed and have successfully implemented for the other Texas and Oklahoma tolling projects.

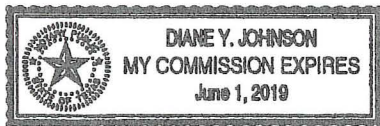
