**SECOND AMENDMENT TO AGREEMENT FOR
 PROFESSIONAL ENGINEERING SERVICES**

THIS SECOND AMENDMENT, is made and entered into by and between Fort Bend County (hereinafter "County"), a body corporate and politic under the laws of the State of Texas, and HR Green, Inc., (hereinafter "Contractor"), a company authorized to conduct business in the State of Texas.

WHEREAS, the parties executed and accepted that certain Agreement for Professional Engineering Services on January 27, 2015, (hereinafter "Agreement") pursuant to SOQ 14-025; as amended by document dated October 13, 2015, (hereinafter "Amendment"); and

WHEREAS, the parties desire to further amend the Agreement to add structural design and details.

NOW, THEREFORE, the parties do mutually agree as follows:

1. Services to be rendered under the Agreement shall be amended to add structural design and details to attach the 16-inch diameter waterline to the proposed bridge widening over Keegan's Bayou.
2. County shall pay Contractor an additional five thousand dollars and no/100 (\$5,000.00), for the supplemental services to be rendered under this Amendment.
3. The Maximum Compensation payable to Contractor for Services rendered is hereby increased to an amount not to exceed four hundred sixty-seven thousand seven hundred forty seven dollars and no/100 (\$467,747.00), allocated as follows:
 - A. \$368,901.00 under the Agreement;
 - B. \$93,846.00 under the Amendment; and
 - C. \$5,000.00 under this Second Amendment.
4. In no case shall the amount paid by County for all Services under the Agreement and this Amendment exceed the Maximum Compensation without an amendment executed by the parties.
5. The time of performance for all Services to be provided by Contractor, including the additional services, shall be extended by six (6) months from the date of termination as provided in the Agreement.

Except as provided herein, all terms and conditions of the Agreement shall remain unchanged.

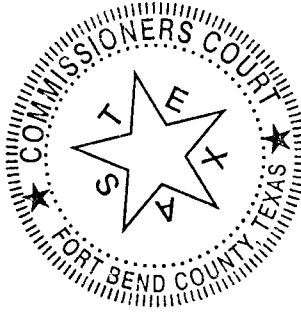

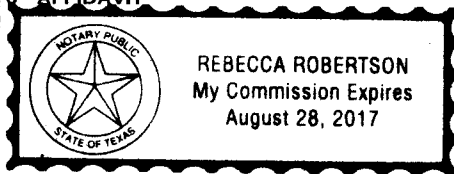
