

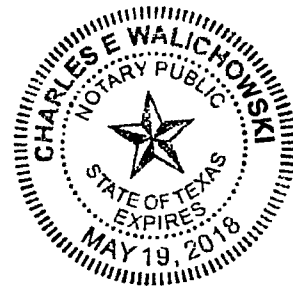

Notice is hereby given of a joint public hearing to be held on behalf of the Arlington Higher Education Finance Corporation on April 20, 2016 at 10:30 a.m., at 600 Travis Street., Suite 4200, Houston, Texas 77002, with respect to the captioned Bonds to be issued in an aggregate principal amount not to exceed \$100,000,000 by the Arlington Higher Education Finance Corporation (the "Corporation"). The proceeds of the Bonds will be issued as part of a plan of finance and loaned to Harmony Public Schools, a Texas non-profit corporation (the "Borrower") for the following purposes:

(1) The purchase of land school sites and the construction, equipment and improvement of charter school facilities at the following locations:

(2) paying the costs of issuing the Bonds.

The Project will be owned and operated by the Borrower. The Bonds are not payable out of taxes and are secured by and payable solely from funds provided by the Borrower.
