 - b. when construction is completed and ready for final inspection

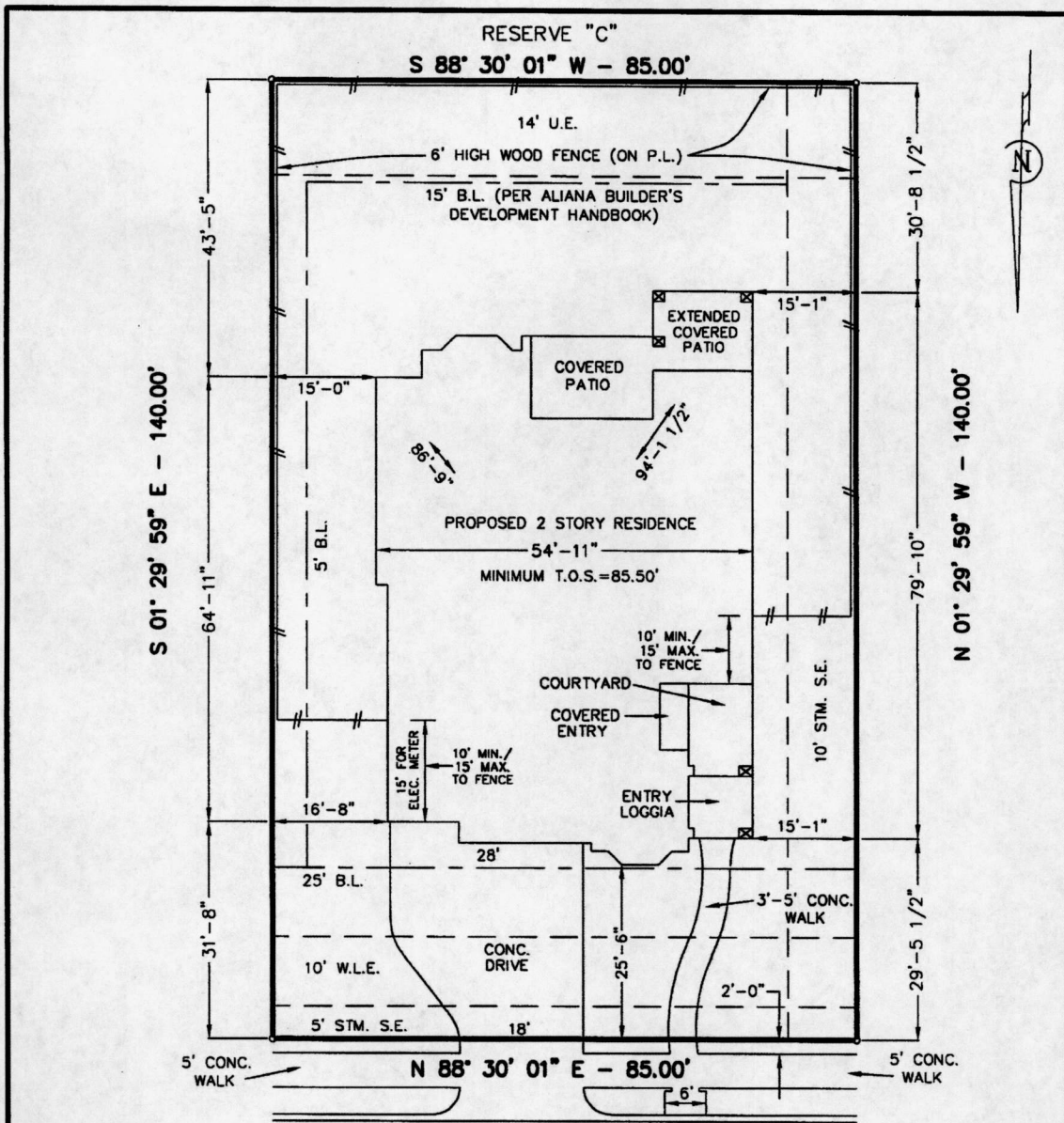
