

**INTERLOCAL AGREEMENT BETWEEN FORT BEND COUNTY AND  
FORT BEND COUNTY EMERGENCY SERVICES DISTRICT NO. 2  
(WILLOWFORK FIRE DEPARTMENT)**

This Interlocal Agreement ("Agreement"), is made and entered into between Fort Bend County, by and through the Fort Bend County Fire Marshal (hereinafter "County") and the Fort Bend County Emergency Services District No. 2 (Willowfork Fire Department), duly organized and chartered in the State of Texas existing under the laws of the State of Texas; hereinafter sometimes called (hereinafter "Fire Department"), providing services to incorporated and unincorporated areas in Fort Bend County, acting by and through the Chief of the Fire Department..

WHEREAS, the County and the Fire Department desire to cooperate with each other in fire protection, fire-fighting, and assistance in emergency medical services; and

WHEREAS, the County and the Fire Department desire to furnish fire protection, fire-fighting, and assistance in emergency medical services to said unincorporated areas of the County; and

WHEREAS, the governing body of the Fire Department has duly authorized this agreement; and

WHEREAS, the governing body of the County has duly authorized this agreement; and

WHEREAS, this agreement is made pursuant to the Interlocal Cooperation Act, Chapter 791 of the Texas Government Code and under Section 352.001 of the Texas Local Government Code.

NOW THEREFORE, in consideration of the mutual benefits to be derived by the parties hereto, County and Fire Department agree to amend the Agreement as follows:


1. County shall purchase and provide for the installation of five (5) mobile and four (4) portable radios ("Radios") through HGAC Contract RA05-15, as described in Exhibit A.
2. Fire Department clearly understands and agrees, such understanding and agreement being of the absolute essence of this Agreement, that County shall have available the total maximum sum of twenty-nine thousand three hundred sixty-nine dollars and 60/100 (\$29,369.60), specifically allocated to fully discharge any and all liabilities County may incur for the purchase and installation of the Radios.
3. Once installation/delivery of the Radios is complete, County assigns any and all rights, title, interests, and warranties in the Radios to Fire Department. Fire Department is the owner of the Radios and carries all rights and responsibilities for the property. Accordingly, Fire Department further understands and agrees that County shall bear no further responsibility for the Radios or for any cost or fee concerning the Radios except as shown on Exhibit A. Fire Department understands and agrees that County is not responsible for repair, replacement, maintenance, license, network access, or for any other cost or fee attributed to the Radios.
4. **FIRE DEPARTMENT SHALL INDEMNIFY AND DEFEND COUNTY AGAINST ALL LOSSES, LIABILITIES, CLAIMS, CAUSES OF ACTION, AND OTHER EXPENSES, INCLUDING REASONABLE ATTORNEYS' FEES, ARISING FROM ACTIVITIES OF FIRE DEPARTMENT, ITS AGENTS, SERVANTS OR EMPLOYEES, PERFORMED**

UNDER THIS AGREEMENT THAT RESULT FROM THE ACT, ERROR, OR OMISSION OF FIRE DEPARTMENT OR ANY OF FIRE DEPARTMENT'S AGENTS, SERVANTS OR EMPLOYEES.

5. Once the Radios have been purchased and installed/delivered to Fire Department, County's obligations under this Agreement are extinguished.


