**MOTION PASSES**

Commissioner Meyers explained why the amount of property tax rate increase is not the actual incurred. The effective tax rate was calculated with the formula the state provides. The Tax Assessor Collector follows a state form used to calculate the tax, which comes out to 3.94%. However, not included in the formula is the property damage related to the recent flood, which will reduce the property values and will reflect a reduction in the amount of increase in property values. By including this to the formula it actually reduces the increase to 2.4%, which is less than the 2.5% of Consumer Price Index for this year and projected for next year. Furthermore, all Counties that provide any type of tax incentives to bring businesses, jobs and economic development to their County are penalized by the amount they contribute toward the effort. If this amount is included, it truly reflects what the County's true tax amount of last year was and the increase is reduced to less than 1%, eight-tenths of a percent. So from this stand point, the formula which the state provides does not reflect the true effective tax-rate that Fort Bend County will experience, instead of 3.9%, the increase is 2.4%.

Judge Hebert stated, for the record, regardless of what the state requires, a 1.2¢ reduction constitutes the total County Tax Rate for this year. This is the third consecutive year the County has managed to reduce the tax rate, which is a good trend. Judge Hebert expressed his appreciation to all who worked together to come up with a budget to make this reduction possible.

Commissioner Morrison asked how much remains in reserve.

Pamela Gubbels, Director of Finance and Investments stated the reserve is 15.5%.

Commissioner Patterson explained the .5% in reserve is a calculated guess due to flood damage and possible tax protest. Also, included in this budget is a pay raise for employees based on a Human Resources study.
