SECOND AMENDMENT TO AGREEMENT FOR COLLECTION OF  
 FINES, COSTS & FEES OWED TO FORT BEND COUNTY  
 FOR THE USE OF TOLL ROAD PROJECTS

This Second Amendment, is made and entered into by and between Fort Bend County (hereinafter "County"), a body corporate and politic under the laws of the State of Texas, and LINEBARGER GOGGAN BLAIR & SAMPSON, LLP, (hereinafter the "Firm"), a company authorized to conduct business in the State of Texas.

WHEREAS, the parties executed and accepted that certain Agreement for Collection of Fines, Costs & Fees owed to Fort Bend County for the use of toll road projects on July 27, 2004 (the "Agreement"), as amended March 4, 2008 (the "Amendment"); and

WHEREAS, the parties desire to further amend the Agreement to correspond with the most current provisions of the Amended and Restated Order Establishing a Toll Rate Schedule for the Fort Bend County Toll Road System.


NOW, THEREFORE, the parties do mutually agree to amend Section 7 of the Agreement to read as follows:

- (a) To impose a cost of fourteen dollars (\$14.00) on each unpaid toll or charge that is referred to the Firm for collection services; such costs to be paid to the Firm upon collection.
- (b) To impose an additional fifty dollars (\$50.00) on each account of an unpaid toll or charge on which a citation has been issued initiating the administrative adjudication hearing process for prosecution by the Firm; such costs to be paid to the Firm upon collection.
- (c) To impose an additional fifty dollars (\$50.00) on each account of an unpaid toll or charge which is presented at an administrative adjudication hearing process by the Firm; such costs to be paid to the Firm upon collection.
- (d) To pay to the Firm 50% of all civil fines assessed by administrative hearing officer or court and collected by the Firm through the filing of a lawsuit to the extent permitted by law.

Except as provided herein, all terms and conditions of the Agreement shall remain unchanged.



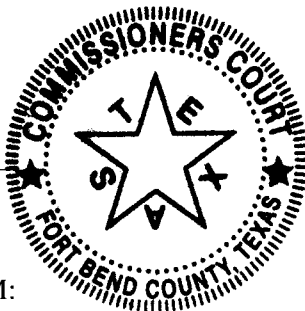


