4. It has been published regularly and continuously since 2008.

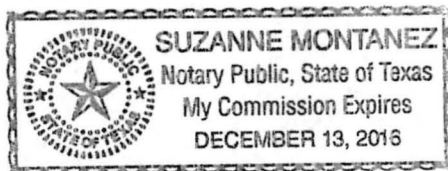


