**RENEWAL OF FOOD TRUCK LEASE AGREEMENT  
 PURSUANT TO RFP 15-091  
TEXAS MOBILE CATERING, LLC DBA THE SAUER KRAUT FOOD TRUCK**

This Renewal of Food Truck Lease Agreement is made on the 5 day of September, 2016 by and between Fort Bend County ("County") and Texas Mobile Catering, LLC DBA The Sauer Kraut Food Truck ("Lessee"), a company authorized to conduct business in the State of Texas.

**WHEREAS**, on October 27, 2015, County and Lessee entered into a Food Truck Lease Agreement ("Lease Agreement") to allow Lessee to lease property located near the County Justice Center for the purpose of operating a mobile food truck pursuant to RFP 15-091 to remain in effect through September 30, 2016; and

**WHEREAS**, under the terms of the Lease Agreement, the Term of the Lease may be renewed annually upon mutual agreement of both parties; and

**WHEREAS**, both the County and Lessee desire to renew the Term of the Lease for an additional twelve (12) months and remain in effect through September 30, 2017, under the same terms of the original Lease Agreement.


**NOW, THEREFORE, IN CONSIDERATION OF THE MUTUAL BENEFITS HEREIN CONTAINED, IT IS AGREED** said Lease Agreement is amended as follows:

**RENEWAL OF TERM.** The Term of the Lease Agreement is hereby renewed for an additional term of twelve (12) months, commencing on October 1<sup>st</sup>, 2016 and ending on September 30<sup>th</sup>, 2017.

**FULL FORCE AND EFFECT.** Except as modified herein, all other terms and conditions of the Lease Agreement shall continue and remain in full force and effect.



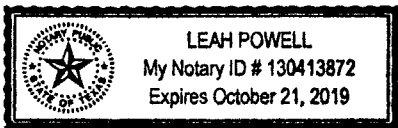
