RE: Funding for a certain deceleration lane along FM 1093 and modification to the Detention to be constructed by Fort Bend County (the "*County*") using funding provided by C.R. Nevada Associates, LLC ("*CRNA*").

Dear Marcus:

This letter agreement (this "*Letter Agreement*") sets forth the agreement of CRNA and the County regarding the funding for construction of that certain deceleration lane along FM 1093 and modification to the Detention depicted on the attached Exhibit "A" (the "*Deceleration Lane*"). We understand that the estimated cost of engineering and constructing the Deceleration Lane and Detention modification is Five Hundred Thousand and No/100 Dollars (\$500,000.00). We also understand that the County's schedule for completing other work along FM 1093 will require that the County initiate work on the Deceleration Lane and Detention modification immediately in order for such Deceleration Lane and Detention modification to be constructed as part of the FM 1093 project. CRNA has provided a plan locating the proposed driveway connection point and the County has relied on that information to initiate changes to the County construction plans for FM 1093.

The purpose of this letter is to confirm CRNA's agreement to reimburse the County for the actual, reasonable out-of-pocket costs incurred by the County in connection with construction of the Deceleration Lane and Detention modification (the "*Reimbursable Costs*") up to a maximum of Five Hundred Thousand and No/100 Dollars (\$500,000.00) (the "*Initial Funding Commitment*"). An initial payment of Twenty Thousand and No/100 Dollars (\$20,000.00) is attached, or being concurrently wired to FBC, to secure the engineering and change order preparation activities. To secure final change order obligation, CRNA shall advance the remainder of the Initial Funding Commitment to the County by check or wire transfer prior to the County's execution of the construction contract change order pursuant to which the Deceleration Lane and Detention modification will be constructed (the "*Change Order*"). Upon receipt of the Initial Funding Commitment, the County shall hold such funds in escrow to be used for the sole purpose of satisfying CRNA's obligations with respect to the Reimbursable Costs pursuant to the terms, conditions, and provisions of this Letter Agreement and such funds shall remain the property of CRNA until such time as they are applied to such Reimbursable Costs.

If the Reimbursable Costs are anticipated to exceed the Initial Funding Commitment, then the County shall notify CRNA and CRNA may elect, in its sole discretion, to increase its obligations hereunder by delivering written notice to County stating a new maximum amount that CRNA is agreeing to reimburse pursuant to this Letter Agreement (the "*Additional Funding Commitment*"). If CRNA


declines to increase its obligation, the change order will not be initiated and CRNA will submit for a permit to add the Deceleration Lane and Detention modification at a later date. Within thirty (30) days following completion of the Deceleration Lane and Detention modification, the County shall provide to CRNA an accounting of the Reimbursable Costs, whereupon the County shall refund any amounts remaining in the Initial Funding Commitment or CRNA shall pay to the County all or any portion of the Additional Funding Commitment as may be necessary to satisfy the Reimbursable Costs.

This Letter Agreement may be executed in multiple counterparts, each of which shall constitute an original, but all of which taken together shall constitute but one and the same agreement. For purposes of this Letter Agreement, a facsimile signature shall be deemed an original signature. This Letter Agreement shall be binding upon and inure to the benefit of the parties hereto and their respective successors and assigns.
