**Health & Human Services: Update on the progress of current 1115 Waiver projects by Fort Bend County and other County stakeholders.**

Dr. Mary desVignes Kendrick, presented an update on the 1115 Waiver projects. The 1115 Steering Committee members were present in court and include: Dr. Kendrick, Dr. Connie Almeida, Dr. Kaye Reynolds, Anne Werlein and Ed Sturdivant, County Auditor. Also present in court, were Partners of the 1115 Waiver Project which include: Carol Edwards, Access Health, Joe Freudenberger, Oak Bend Medical Center, George Patterson, Texana and John Cramer, Memorial Herman Hospital. Dr. Kendrick gave an overview of the 1115 Waiver projects in Fort Bend County, the impacts and highlights, the physical issues such as the intergovernmental transfers, costs savings, costs avoidance, challenges and next steps going forward. She indicated there are 30 projects ongoing in Fort Bend County which fall into two main categories: improving quality of life of residents and reducing unnecessary utilization of health care resources. Dr. Kaye Reynolds presented what happens to patients with Unmanaged Chronic Disease. Dr. Connie Almeida presented the enhanced continued care of individuals with Unstable Behavioral Health Disorders. Ed Sturdivant, County Auditor presented the cost savings and total value of the projects.
